<b>RESOLUTION 2012-01</b>	A Resolution designating J.P. Morgan Chase Bank as a depository for the Village of Sunbury.
<b>RESOLUTION 2012-02</b>	A Resolution repealing Resolution 2012-01 naming J.P. Morgan Chase Bank as a public depository and declaring an emergency.
<b>RESOLUTION 2012-03</b>	A Resolution amending Resolution 2011-14 estimating the probable aggregate maximum amount of active funds and inactive funds to be deposited by the Village of Sunbury and declaring an emergency.
<b>RESOLUTION 2012-04</b>	A Resolution designating the Delaware County Bank and Trust Co. as a public depository for the Village of Sunbury and declaring an emergency.
<b>RESOLUTION 2012-05</b>	A Resolution designating Fifth Third Bank as an additional public depository pursuant to O.R.C. 135.12(D) for the period from February 21, 2012 through February 20, 2017 and declaring an emergency.
<b>RESOLUTION 2012-06</b>	A Resolution designating J.P. Morgan Chase as an additional public depository pursuant to O.R.C. 135.12(D) through February 20, 2017 and declaring an emergency.
<b>RESOLUTION 2012-07</b>	A Resolution accepting the report of the Village of Sunbury Tax Incentive Review Council (TIRC) on the status of the Tax Increment Financing (TIF) Area Program for program year 2011 and accepting the recommendations of the TIRC that all existing agreements be continued and declaring an emergency.
<b>RESOLUTION 2012-08</b>	A Resolution accepting the report of the Village of Sunbury Enterprise Zone Tax Incentive Review Council (TIRC) on the status of the Enterprise Zone Programs for year 2011 and accepting the recommendations of the TIRC concerning agreements an declaring an emergency.

<b>RESOLUTION 2012-09</b>	A Resolution authorizing the transfer of the unexpended balance of the Water Utility Deposit Fund in the amount of \$32,751.17 to the General Fund pursuant to O.R.C. 5705.14.
<b>RESOLUTION 2011-10</b>	A Resolution authoring transfers from the General Fund to the Water Fund and Sewer Fund for reimbursement of prior years water deposit credits.
<b>RESOLUTION 2012-11</b>	A Resolution accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor and declaring an emergency.
<b>RESOLUTION 2012-12</b>	A Resolution authorizing the Village Administrator to prepare and submit an application to participate in the Ohio Public Works Commission State Capital Improvement and/or Local Transportation Improvement Program(s) in connection with the 2013 Village of Sunbury street improvements project and to execute contracts as required and declaring an emergency to allow said application to be submitted prior to grant application deadlines.
<b>RESOLUTION 2012-13</b>	A Resolution authorizing the transfer of \$7,542.00 to the General Fund pursuant to O.R.C. 5705.14(D).
<b>RESOLUTION 2012-14</b>	A Resolution authorizing the transfer from the General fund to Cemetery Fund in the amount of \$7,542.00 pursuant to O.R.C. 5705.14(D)
<b>RESOLUTION 2012-15</b>	A Resolution approving the Delaware, Knox, Marion, Morrow Solid Waste Management District Plan Update and declaring an emergency.

<b>RESOLUTION 2012-16</b>	A Resolution authorizing the execution of an Energy Management Agreement with Trebel, LLC and declaring an emergency.
<b>RESOLUTION 2012-17</b>	A Resolution authorizing execution of Electric Sales Agreement with Border Energy Electric Services, Inc. for provision of electrical energy for Village of Sunbury facilities only for a two year period and declaring an emergency.
<b>RESOLUTION 2012-18</b>	A Resolution in support of the Mid-Ohio Regional Planning Commission Big Walnut Watershed Planning Partnership and the Big Walnut Watershed Balanced Growth Plan
