

SUMMARY OF ORDINANCES FOR THE VILLAGE OF SUNBURY FOR CALENDAR YEAR 2013

<p>Ordinance 2013-01</p>	<p>An Ordinance setting the 2013 Annual Appropriations and authorizing expenditures for calendar year 2013 pursuant to applicable provisions of the Ohio Revised Code.</p>
<p>Ordinance 2013-02</p>	<p>An Ordinance providing for the issuance and sale of notes in the maximum aggregate principal amount of \$2,405,100.00 in anticipation of the issuance of bonds, for the purpose of paying the cost of (i) receipts, improving and reconstructing the intersection of Morning Street and Cherry Street, (ii) acquiring real estate for park purposes, (iii) constructing the Granville Street extension bridge, (iv) improving municipal streets and parking lots in proximity to the Town Hall Square, (v) the Village's portion of the cost of improving public streets and easements by improving U.S. Route 36/State Route 37 and Kintner Parkway and (vi) improving the vehicular transportation system in the Village.</p>
<p>Ordinance 2013-03</p>	<p>An Ordinance accepting the recommendation of the Planning and Zoning Commission to approve the final plat of Sunbury Meadows Subdivision Section III-B with contingencies and declaring an emergency.</p>
<p>Ordinance 2013-04</p>	<p>An Ordinance approving the application for plan review and zoning certificate of Fifth Third Bank for a drive-up ATM location in Sunbury Plaza parking lot conditional upon final engineering approval.</p>
<p>Ordinance 2013-05</p>	<p>An Ordinance amending the regulations of the Village of Sunbury Tree and Landscape Commission coordinating submittal of the annual report to Sunbury Village Council with an annual report required via participation in Tree City USA program in December of each calendar year.</p>

Ordinance 2013-06	An Ordinance authorizing the Mayor to execute an employment agreement addendum with Kathy Belcher as Village Fiscal Officer providing increased compensation and benefits and expanded job responsibilities and declaring an emergency.
Ordinance 2013-07	An Ordinance approving the construction improvement plans for Sunbury Meadows Section V Phases A & B subject to contingencies and declaring an emergency
Ordinance 2013-08	An Ordinance authorizing invitations for bids for a Town Hall Roof Replacement Project and declaring an emergency.
Ordinance 2013-09	An Ordinance amending the rules and regulations of the Village of Sunbury Cemetery aka Sunbury Memorial Park to provide revised pricing and establishing regulations regarding cremated remains section.
Ordinance 2013-10	An Ordinance awarding the Town Hall Roof Replacement contract to B & T Roofing pursuant to their lowest and best bid for a copper replacement roof in the amount of \$151,959.00 and declaring an emergency.
Ordinance 2013-11	An Ordinance providing for the employment of David J. Brehm as Solicitor for the Village of Sunbury for a two year period.
Ordinance 2013-12	An Ordinance approving the application for Plan Review and Zoning Certificate for Joann Higenbergen for a future Subway restaurant and associated commercial site development subject to conditions and declaring an emergency.
Ordinance 2013-13	An Ordinance approving the editing and inclusion of certain ordinances as parts of the various component codes of the Codified Ordinances of Sunbury, Ohio, and declaring and emergency.
Ordinance 2013-14	An Ordinance awarding the 2013 Street Improvements Project to Shelly and Sands pursuant to their lowest and best bid in the amount of \$330,605.00 and declaring an emergency.
Ordinance 2013-15	An Ordinance establishing an exemption for no hunting requirements within the Village

	of Sunbury for agricultural property in excess of 50 acres.
Ordinance 2013-16	An Ordinance authorizing the purchase of an on officer video camera system for the Village of Sunbury Police Department including service agreement and video storage agreement.
Ordinance 2013-17	An Ordinance approving the final plat of Sunbury Meadows Subdivision Section V, Phase A & B subject to contingencies and declaring an emergency.
Ordinance 2013-18	An Ordinance approving the execution of the purchase agreement for real estate located at the corner of Columbus Street and E. Cherry Street for the sum of \$69,000.00 subject to contingencies and declaring an emergency.
Ordinance 2013-19	An Ordinance approving the exercise of a right of first refusal to purchase real estate known as the Breece property located on Rainbow Avenue for the price of \$25,000.00 and authorizing delivery of notice of exercise to seller and declaring an emergency.
